## **Annual General Meeting Minutes**

Meeting Held: 27<sup>th</sup> August 2022 Location: BBC Clubrooms

#### 1. ATTENDANCE AND OPENING

The meeting was opened at 10:31am by Andy Males (President)

#### 2. CONFIRMATION OF PREVIOUS MINUTES

Minutes from the previous AGM held on 4<sup>th</sup> September 2021 were circulated to attendees before the meeting began. Esther Saunders moved that these minutes be held as a true record of that meeting. Seconded by Judy Clarke.

#### 3. PRESIDENTS REPORT

Andy Males read from his prepared report. The full text of the report is attached to these minutes.

Moved for acceptance by Colin Saunders, Seconded Jennie Drennan.

#### 4. TREASURERS REPORT

Club Treasurer Brian Wade presented the Financial Report for 2021/22(attached). Brian reports a total positive cash flow of \$1,902, including receiving a total of \$80 in interest from our \$55,000 invested. Total funds held by the club is \$65,448 including \$10,600 in the cash account. Table fees \$34,258 (an improvement over last year which was affected by COVID), total income \$53,442, and total expenditure \$51,620 – less than last year. Capital expenditure was \$7,889, compared with \$13,571 in the previous year. The state government electricity subsidy expired in March, so net costs for 2021/22 were \$714.

Congress financials show a profit of \$1,540, but this was significantly boosted by sponsorship – without which we would have made a loss. The club is looking at an alternative venue, but it has not yet confirmed.

A token system will be introduced as an optional way of paying table fees, with a nominal starting date of 1<sup>st</sup> September. This will help the club move away from cash as much as possible. EFTPOS facility has also been considered, but not proceeded with due to transaction costs.

- Gareth Braid asked Brian to clarify the cash on hand figure given it includes an unusual additional sum. Brian replied that indeed the cash on hand on the 30<sup>th</sup> June figure is inflated by approximately \$2700 due to the club having received an insurance payout for repairs, but the works had not been completed at that date.
- Andy Males discussed how tokens will operate and the potential of increased table fees (to be discussed later in the meeting). Brian confirmed that tokens will be collected from the Treasurer, either by bringing in larger amounts of cash or electronically transferring the money to the club. We will limit purchases to 10 tokens to begin with.

Andy Males read the Auditor's report letter (attached).

John Ferguson moved that the meeting accept the Treasurers report. Seconded by Marianne Viebke. Carried.

#### 5. APPOINTMENT OF AUDITOR

Andy Males moved that we re-appoint Lyndon Edwards for another year. Members present agreed.

#### 6. BRIDGE COORDINATORS REPORT

Brian Wade read from his prepared report on behalf of Marianne Viebke.

The full text of the report is attached to these minutes.

Esther Saunders added Eliane Boom as another member who has contributed to the lessons.

Colin Saunders moved that we accept Brian's report, Seconded by Minetta Hall. Carried.

#### 7. MEMBER FEES

The committee presented an unchanged membership fee, but an increased table fee structure.

- Brian Wade noted that the Youth member fees currently do not apply to anyone and are unlikely to get a significant number of them, but Esther is working towards youth development sessions.
- Brian discussed that the increased table fees are intended to keep the club financially strong. It was noted
  that cleaning costs have increased by 8%, and council rates have increased by 5% this year alone. It is
  believed table fees were last increased at least 8 years ago. Brian reported that he has run financial
  forecasts with the existing fee structure, and the proposed fee structure in this scenario increases income
  by approximately \$5000 annually.

Colin Saunders moved that accept this fee structure. Seconded by Stella Dixon. Unanimous vote in favour.

#### 8. APPOINTMENTS TO APPEALS AND FACILITATORS PANELS

An updated list of recommended panel members was proposed to the meeting.

#### 9. ELECTION OF MANAGEMENT COMMITTEE

During the nomination period, we received one nomination for each of the *President*, *Vice-President*, *Treasurer* and *Bridge Coordinator* positions, and four nominations for ordinary management committee members. (See attached). As per 12.1(a) and 12.1(c) respectively of the club's rules, these people are declared elected.

 Andy Males called for nominations from the floor for the Secretary position. Judy Clarke nominated Minetta Hall, which was seconded by Margie Mullen. Minetta accepted this nomination. A show of hands showed those attending in support.

#### 10. NEW BUSINESS

#### 10.1. Special Resolution: Renaming of 'Junior' member type to 'Youth' member

Brian Wade spoke to this resolution, primarily this is to ensure consistency with the terms used by the ABF.

Brian Wade moved the resolution "To amend the Bunbury Bridge Club constitution by changing the word 'junior' to 'youth' wherever the word 'junior' is used". Motion seconded by Gareth Braid.

Andy Males called for a show of hands with resulted in 36 members in favour, and none against or abstaining. Motion succeeded.

#### 10.2. Special Resolution: Approval of expenditure for air-conditioning

Andy Males reported that the genesis of this item was a suggestion received by the management committee supported by 17 members that the

Colin Saunders spoke against the motion, reporting that there are significant faults with the building structure/cladding and that these should be our priority. Colin mentioned loose fascia, repainting the roof, and recladding the exterior of the building as more important, and said it was ludicrous for us to be spending on this item, which we likened to a Rolls Royce solution when these other items need to be done. Colin also mentioned that am air-conditioning contractor, who he asked, believed that adding a split system to the "South" end of the room, and eventually replacing the "North" unit would be sufficient. He referred to the previously suggested cassette units to be ugly-looking box things and said that their attachment to the roof structure was a further unknown factor.

Marianne Viebke reported that a maintenance inspector provided a report to the club on maintenance items about 5 years ago, and she didn't believe the items Colin mentioned were included – asking for these claims to be substantiated. Marianne believed that the fixing and finishing of the cassette units were clear from the quotes obtained at the time and further called for taking the air-conditioning problem away from the Directors.

Patrick Smith asked that we focus on the air-conditioning systems and reported that part of his non-attendance at the club in recent times was because he found it uncomfortable. He believes that the myths of other clubs having similar problems, and the age of the units have been dispelled. Patrick feels that the current units work well when operated correctly. He further reported doing testing of the current system, which worked very well when started early, and that the total cost of the electricity used was in the order of \$3 per hour. Patrick was not in favour of the removal of the ceiling fans, suggested that the roof structure did not suit cassette-style systems – and felt that split-system air conditioners would be better.

Norm Smith stated that there is a lot of work to be done, and in his personal view, the current units work great. He believes the main issue is the cold air – drafts – from the units affecting nearby players.

Jock Mullen spoke to the motion being a maximum allowance for the committee to proceed, and the detail of how it is to be achieved will be left to them to implement.

John Ferguson reported also engaging an air-conditioning contractor, and said the result was like that which Colin Saunders mentioned – of not favouring cassettes, with plenty of other options. The preferred option appeared to be replacing the 'North' unit and adding a 'South' unit for an indicative cost of about \$17,000.

Margaret Duce said that she believes some of the problems are due to people not using the current systems, and that the issues seem worse since the entrance works a few years ago. However, we need a plan for when one of the current systems fail. Margaret further says that she would just like it to be warm.

Esther Saunders queried whether the motion was for the committee to spend up to a total of \$25,000. Andy Males confirmed that this is a maximum and was sure that the committee would prefer to spend less if a suitable solution was possible.

Patrick Smith said that he felt the item was premature, and that we should wait until we have a detailed plan and firm quote.

Fred Clarke reported experiences with excellent air-conditioning systems in Dunsborough, and that he likes the idea of a new unit at the 'South' end of the building.

Brian Wade moved that the membership "approve capital expenditure of up to \$25,000 for air-conditioning system replacement." Motion seconded by Esther Saunders.

Andy Males called for voting by show of hands. 31 members voted in favour, 5 against with none abstaining. Motion succeeded with 86% in favour.

#### 11. OTHER BUSINESS

#### 11.1. Youth Bridge (Esther Saunders)

Esther discussed how BAWA, Australian Bridge Federation and the World Bridge Federation are agreeing that the future of Bridge is in Youth bridge. Esther has recently received several tips in introducing cards to 'youth', particularly encouraging the use of card games that use standard cards (e.g. not Uno or similar), and moving into trick-taking games. Esther further encouraged members to play cards with younger family members.







#### YEJ22 BRIDGE COORDINATOR'S REPORT

#### COVID19

Unlike the previous year, there was minimal disruption to club activities apart from players needing to comply with government, ABF, BAWA and club directives regarding vaccinations, social distancing and protective measures (masks). Player numbers were up 5% for the year ending June 2022 compared to the previous corresponding period. The club thanks all members for their adherence to policies and observance of procedures throughout the year to keep as many members as possible safe and healthy.

#### **Lessons & Training**

In October 2021, Esther Saunders and her assistants including Joanne, Colin, June, Chris, Di, Dee, Debbie and others embarked on an ambitious program of Tuesday night lessons targeting developing players. In all, 23 lessons were delivered and more are scheduled. Player participation was excellent. A series of four workshops was also provided to assist players to correctly compile a systems card. Esther's work in this space is very much appreciated by both the players and the club. In respect to beginner players, a three week course was completed recently and Esther and Joanne produced a detailed workbook covering the course content.

#### Congress

For the first time in three years, Bunbury actually held their annual congress in April 2022. Whilst the player numbers were lower than anticipated, the congress was a success with special thanks to Esther (the convenor) and her many assistants who helped with preparatory work and organization over the congress weekend. It is intended to relocate to a different venue for the 2023 congress and this promises to be refreshing and rewarding for all involved.

#### **Club Championships**

Club champions for the past year were:-

2021 Peter Morgan Teams Championships: Esther & Colin Saunders, Andy Cayley and Anne-Louise Dubrawski.

2022 Moth Anderson Pairs Championships: Colin & Esther Saunders.

#### Special Player Achievements

Australia Wide Novice Pairs: Linda and Norm Hoskin achieved 4<sup>th</sup> placing Australia wide in the <100 master points category and 1<sup>st</sup> placing in the <50 master point category.

ANC Restricted Qualifying Event: Colleen Skipsey and Brian Wade ranked 1<sup>st</sup> but unable to represent WA in Adelaide due to prior commitments.

Country GNOT: Colleen Skipsey and Colleen Long ranked 2<sup>nd</sup> and so join Murray Webber and Kate Boston for the trip to Brisbane in November to play off in the GNOT finals.

#### **Player Numbers**

The charts attached to the Treasurer's report show the player participation and number of members from 2011 to the end of July 2022. The charts highlight the impact of COVID in 2020 when both member numbers and player participation dropped significantly. Member numbers have stabilised at around 110 for the past couple of years but there is an expectation that these numbers will reduce again by up to 20 members at the end of this year. Player participation by session is both up and down but it interesting to note that the Friday session now exceeds Monday for the first time as the most popular session. The downward trend in player numbers is a concern as the 'health' of the club is dependent on good playing numbers to ensure financial viability and a general feeling of well-being within the club. We all look forward to better times ahead and hopefully the training and player development sessions will not only encourage new members but also improve the bridge playing standard within the club. These are important challenges for future management committees.

#### **Thanks**

Finally, on behalf of Marianne, a thank you to all persons who have contributed to the running of the club over the past year. Many people assist in so many ways and all in a voluntary capacity. In particular, thanks to the directors and the dealers. They give of their time freely and willingly on a continuous basis.
